ПРЕЗИДЕНТА РОССИЙСКОЙ ФЕДЕРАЦИИ

О подготовке программы социальных реформ

В целях последовательного осуществления курса государства на обеспечение конституционных гарантий прав граждан в социальной сфере и укрепления социальной стабильности общества **п о с т а н о в л я ю:**

1. Образовать Государственную комиссию Российской Федерации по разработке программы социальных реформ.

Утвердить Председателя Правительства Российской Федерации Черномырдина В.С. руководителем указанной Комиссии.

2. Руководителю Государственной комиссии Российской Федерации по разработке программы социальных реформ Черномырдину В.С. :

обеспечить в 2-недельный срок формирование состава Комиссии;

провести в 3-месячный срок необходимые консультации по вопросам деятельности Комиссии с представителями палат Федерального Собрания Российской Федерации, органов государственной власти субъектов Российской Федерации, а также ведущих политических партий и общественных движений, российских профессиональных союзов и объединений предпринимателей;

представить к 1 октября 1996 г. проект программы социальных реформ в Российской Федерации на период 1996-2000 годов.
