Having recently been in Oklahoma City, Yugoslavia, China, India, and Africa, I have witnessed firsthand how it is possible for the survivors to look beyond their incredible losses and rebuild their communities with a new appreciation for the inestimable value of each person.

The Global Peace Initiative has been founded to respond to the human suffering resulting from hatred, sectarian violence, terrorism, and armed conflict around the world. The organization's mission, to restore human dignity to people persecuted for their beliefs, attacked in the name of culture, and massacred for political gain, will help to define the role of human rights organizations in the 21st century. While others do the important work of advocacy and traditional prosecution for the violation of human rights, we will work—in word and deed—to demonstrate the singular power of love and the elementary truth of our common humanity.

We are grateful to President Moi for the character and courage he is demonstrating in leading his nation in this day of remembrance and consecration. On this most special day in Kenya, we invite you to join other world leaders who will be coming to Nairobi to witness the triumph of the human spirit.
